Practitioner Course Tuition

Students have 2 options for payment of tuition for Practitioner Training courses.

1.) Payment in full at the time of registration.

Students can elect to pay the tuition and fees in full for the year at the time of registration.

Total tuition when paid in full at the time of registration = \$900

2.) Payment Plan

Students can elect to pay the tuition and fees in 3 installments, paid at the first week of each term. Please note all Payment Plans include a non-refundable payment plan fee.

Total tuition when paid utilizing a payment plan = \$1000 (333.33 per term).
